In addition to the above list of response activity, our security also monitors the bus parking lot, conducts daily tours of our roads and checks our community buildings to make sure they are secure.

*PFA- there were two PFA/s in October, one permanent and one temporary. The temporary order has since been granted to permanent.

**Attempted break ins. There have been two attempted break ins in November. One was discovered by Security while conducting house checks on a part time home and the second occurred while member was home and heard noise outside the home. The attempt was discovered the next day by the homeowner who reported finding a ladder from his yard against the home. There were no successful entries into the homes however, windows were tampered with. The property discovered by security is on Iroquois trail. PSP is handling the investigation. A person alleging being connected to the Dept of Forestry contacted security to obtain information regarding the attempted break-in and was referred to PSP. The other property is on Conashaugh Trail. That member was provided paper work to complete and asked to contact PSP. Awaiting update from member.

Note regarding dogs at large. The office received additional complaints for dogs at large stemming from one member's home (as reported last month). Videos and complaints have been and will continue to be forwarded to the Pike County Dog Warden. The pending Magistrate hearing addressed in last month's report took place and the member did not show up for the hearing and was found guilty on matters heard by the judge as submitted by the Dog Warden. The owners have been fined by the court. As previously reported, once the dog warden opened his case the office was notified to cease and desist issuing fines. This is because we cannot (double) fine an owner for matters being fined by the Dog Warden.

Unattended Fire- security found an unattended fire on Conashaugh Trail. Alerted the person and the fire was extinguished only to re-ignite setting front yard on fire. Although two members called in burn notifications during November, security reports that several members did not call them. The Rules and Regs committee plans to review burn regulations in January.

Property checks

An updated list of standing properties requesting checks was sent to St. Moritz on November 7, 2023. Printed copies provided to security personnel on site.

Security has been provided with member listings and a large map of the community to help better identify property owner info.
